October statistics are due! Please report them on our website or in the sidebar to the left as soon as you can. Statistics for the prior month are due on the 5th of the month.

The monthly courier statistics, which we ask you to self-report via a simple website form, are very important. Just as your board asks to see your library use statistics like circulation, program attendance, door count, etc., MALA and the State Library need measures to gauge the courier service's effectiveness. If you don't report your courier numbers, we can't get a sense of how much actual use there is, or how best to adjust our service model to optimize delivery routes. Thank you for getting those statistics reported to us.

MALA staff attended the Kansas Library Association Conference in Overland Park last week. We had a special nonprofit table outside the exhibit hall and were able to talk with librarians about our regional courier service, and most importantly, about our upcoming training and professional development calendar.
