### **Mandatory Survey Response**

Several times a year MALA is required by the terms of the LSTA grant administered through the State Library to provide interim reports for the current grant year; and two times each year we request delivery information from you through a mandatory participant survey that is included in the grant reporting. MALA recently sent out an October 2020 Survey to the directors of all of our LSTA libraries. We ask that only ONE person at your library fill this out – either the director or ILL coordinator. This very brief survey will only take you a couple of minutes to complete and is due by Monday, October 26. To date, we have received about 50% of responses.
