Reporting Closures and Holidays to MALA

We view Holidays and Closures as two separate things, and therefore have two methods of reporting them.

Closures: If you have an IMMEDIATE/sudden closure due to inclement weather, road closure, broken pipe, power outage or any other emergency please report those using the <u>Courier Delivery</u> <u>Service Issues form</u>. It is very important that you let MALA know as soon as possible that your library will be closed, so that we can inform your courier. If you do not have easy access to this link, please email both Linda and Mickey. Add both of our email addresses (<u>linda.tarantino@mid-americalibraryalliance.org</u> and <u>maladirector@mid-americalibraryalliance.org</u>) to your library's distribution list. Both of us need to be notified in the event one or the other is out of the office. Thanks.

Holidays: If you have not already done so, we want you to report all of your SCHEDULED 2020 Holiday Closures on our new form located in <u>Courier Services</u>. You will see that MALA's 11 annual courier holidays are already pre-checked on this form. (MALA Courier Holidays are days that you do not get delivery service.) On this form, we ask you to report any other scheduled holidays that you

have throughout the year – this includes staff meetings, retreats, etc. Please don't hesitate to contact us with any questions.

Courier Issues

Mis-delivered items

From time to time, your library may receive items that are not meant for you. There is sometimes confusion between Wellsville (MO) and Wellsville (KS), as well as Atchison (KS) and Atchison County (MO) -- not to mention Doniphan County (KS) and Doniphan-Ripley County (MO). If this confusion is the result of a sorting error by Henry Industries, the misdelivered item(s), once discovered, needs to be returned to your delivery driver. The item needs to be put back in the delivery network to the correct location. Please, do not attempt to mail misdelivered items to the correct library. They go back to the courier driver, or, as a last resort, they should be sent to MALA with a note enclosed. Sometimes, the driver will carelessly deliver a full tote of bags that belong to another library. Same procedure here – put the items aside, contact MALA and return the items to the driver. Don't attempt to redeliver them yourself. Thanks.

Courier bag labels with old information?

We've had a few instances where libraries are asking about out-of-date information, like a former street address, on their courier label. We update the label file very time we receive new information from a library, so that shouldn't ever happen. What we've found out is that the library is using an old download of the PDF file that has outdated label information. The Henry PDF file on our website has a version number and a date – the latest file is Version 21, dated 10/05/2020. Please use the latest version to generate labels. The extended service label maker automatically uses the most updated information available.

Lead time for courier supplies

We've had a number of "emergency" bag requests in the past few weeks. Please bear in mind that we cannot get supplies to you any faster than the courier system allows them to be delivered – it takes about a week. We generally fill supplies requests either same day, or next day, but it takes time to get them to you through the courier delivery network. Please, never let yourself get to a place where you have no courier bags. Allow 7-10 days delivery time to be on the safe side, and contact us if you don't get your requested supplies in a reasonable time frame. You can request totes, MALA bags in various sizes, TAE bags and MOBIUS bags. We will be happy to send you what you need.
