Volume categories explained

MALA's agreement with Henry Industries for the delivery of library resources across the State of Missouri includes the number of items delivered from locations (your reported monthly stats) and the number of days libraries are serviced to keep the flow of materials equitable across the state. This resulted in a recommended formula used for the last 3 years, and continued into the new contract. It is also used by the State Library to help them determine grant-funded stops.
