Learn how SLCL has successfully brought virtual library programming to individuals at the St. Louis County Justice Center, with more than 60,000 views of 50 library programs in just six months. Learn how the Reference department supports currently incarcerated patrons through their Reference by Mail service, as well as supporting formerly incarcerated patrons with starting their own business through the Small Business Launchpad. Finally, learn how innovative collaboration among Bail Project St. Louis, prosecutors, defense attorneys, and the circuit court led to the creation of the Tap-In Center at St. Louis County library. The Tap In Center provides a welcoming and safe space for individuals to meet with an attorney, get their case information and court date, apply for a public defender, and even resolve active criminal warrants--all in a safe place without risk of arrest.
